October 2021

Good morning, ASC Body,

P and P committee met on Wednesday, October 6, 2021 at 6pm in Zoom room #1. In attendance were Monica F., Yvonne C., Ted T., Jeff S., Christine Z. and myself. We reviewed the items on pg.10 under "Elections," and decided to combine items 7 and 8 since they were related to the same topic on how to handle elections when there are more than 2 candidates running for a position. There was also a minor change in the wording to provide better clarity. Please see Figure 2.1 for these edits.

7. If a candidate does not get the majority vote, and there are three [3] or more persons running, the two [2] with the most votes will then compete for the position. If the two [2] with the most votes do not get the majority vote, the position is held vacant until the next ASC meeting.

Next, we reviewed what was previously item 11, (now item 10) to edit the language and numeration over the procedures for officers serving consecutive terms or an extension of term. We added the phrase "Extension Clause" and the condition that an officer would have to be willing to extend their term so policy would not read as though Area could force someone to continue in their position against their will. Not that this ASC would ever do that, but we felt the need to clarify that. See Figure 2.2 for reference.

- 4 10.A second term of office can be held consecutively. However, an office cannot be held for more than two terms. A 51% majority vote by GSR/Alternate/Designated Representative is required for continuation of office. Once two terms of office have been held, a full term of the position must pass in order to be eligible for a nomination for that office again.
 - Extension Clause: In case an officer's term is over and there are no nominations, the officer's term can be extended, if the officer is willing, on a month to month basis. However, these extensions will not exceed more than three [3] months.

Finally, we made somewhat of a plan to meet and discuss points of consideration in preparation for the upcoming Area inventory, however the date for this meeting is to be determined.

I'd like to take a moment to express my gratitude to P and P Alternate, Yvonne C and everyone on the P and P committee for making each meeting a productive and efficient one. And thank you to this ASC body for allowing me to serve alongside them.





The average session is about 1 minute and 41 seconds, which is up 10%. There have also been 166 unique visitors (-8%). There have also been about 123 new visitors, and 43 returning visitors, (273 accessed from Google, which is +34%). The top pages of the website are the meetings section, which is at 370, (+21%).

- -We had a discussion on the Children's Summit on Suicide and Mental Health in Las Cruces, NM that we attended on September 15th. Our group consensus is that we would like to continue to attend this event in the future now that we know what to expect.
- -Reports on contact efforts:
- -EPBH (Any updates?) Pete shared information on how to proceed with the panel for outpatient program Mon-Fri, 9:30- 3:30 They have dual diagnosis, in-patient program, and more severe patients. They are hoping we could provide an H&I panel for their dual diagnosis group. One or two staff members may be present at the meeting. They would like panel to come at least once per month or more often if possible. There are no requirements now on our part as far as background checks or orientation. She reported on updates from Ysleta Del Sur Pueblo, Homewar Bound-Trinity, Aliviane, and Recovery Alliance and their recovery efforts. Punto de Partida is having a donation drive for blankets, jackets and backpacks for unhomed populations for the fall. The Ysleta Del Sur Pueblo will be having a suicide prevention training.
