Just an idea of what it looks like. 2^{nd} – home screen. Events flyers activities. Links. Registration online for conventions. Meetings list. Contact us.etc, 3^{rd} has all the same stuff. just looks different. Has some of the virtual online meetings. We can link to Region or World.

The reason we want to do this is because we don't have to ask region to update our meetings or to do things for us. They change the password and was recently unable to update ep info. But now we don't have to wait for them. We can just link up to them. We can create our own. These are just examples. New ppl ask about our website. I have to refer them to region and walk them through it. Its \$156 per year or \$13 per month. Ted - is this a living doc where you can go in and change the info the pics etc? Tracey - that's right. The webteam would have access. Also have a contact to email us. Submitting a motion to approve the funding. The voting is already done.

Corina – Tracey did an awesome job. Monica – I feel very comfortable with this website committee. Because you have a committee instead of just one person. Monica – do we need to vote on the content? Or just the money? Just the money although the EP NA would probably want to vote on the content too

Vote to extend. Yes

Ted – What about Security. Tracey – to Monica. If we do get funding then we can arrange a web team meeting. Open to all. That way we can brainstorm on the webpage we want to do. We can use one of the formats we have and go from there. It will be up to the web team to create it and add. And Ted once we pay for the webpage it is owned by us. Let's say its owned by me and by Michael. Then no one can do anything to it.

Corina – please go to meeting for more information. The ad hoc was there as well. Encouraged to put meetings on world web. Can you change the owners?

Monica – Set up an area email. Then website set up to area email account. It would be just like the bank acct.

Share 2- Jeff – Virtual meetings and Security. We began getting attacked after we put up the meetings on virtual site. There are a lot of random ways ppl can create mischief. We are doing a lot of research on how that works but they are very creative. Jay – I would think that if I was paying money to a company and having all these issues they should be fixed. Has anyone contacted Zoom? We had passwords at one time. Jeru – passwords are not 100 reliable. Some glitch where you can put the password but I can't. It will be the same pw but doesn't work. So pw is not great. This is why we set it to waiting rooms so we can see who is trying to come in. Jaime – suggest to get gsr more involved to attend the adhoc to at least put some feedback or take some info back to homegroup so we know what the adhoc is trying to do. Maybe the chairperson to get more knowledge. Jeff I have been host at meetings and there is no way for chair persons to also handle all of the technical stuff. Monica – its an open group so my concern is whether or not we are letting anybody in. the waiting room allows one person at a time rather that 10 at a time. How do we know who is an addict and who isn't? How do we know we are not letting in newcomers. Jeru - we bring them in one by one and watch what they do. We pay attention to if they are trying any shenanigans. Jeff - we do ask them to turn on the camera and some leave. Chris - I agree we should have 1 chair facilitator and one host. We may need to change platforms. I don't think information is being decimated timely. Maybe a weekly newsletter?

Sunday night meeting for adhoc. There is really not a homegroup. There is a rep that has been here but no homegroup. We decided to keep it open because we feel it is important. Also, for world. It is the hmegrp responsibility.

Vote to extend. Christine – Members getting kicked out worries me. If someone gets kicked out can they come back in? Jeff - if someone is removed they have to create a new profile. Only those that do something extreme get removed and only from those meetings. You can also report them to zoom. We also have ppl saying they are part of zoom tech support and are actually bombers. Christine - so they are removed for life if they get kicked out any meeting using that id they cannot enter. So for that person to whom that happened at NewComers we will help but NC uses their own acct so we are not involved with that.

Juanita – Regarding HI meeting, can those be bombed? Jeff- They can but those meetings are not posted. Also I give the virtual meeting list to clients where I work. Juanita - If they don't use the camera do they get kicked out? Jeff – we don't. As we learn the names we can also chat back. We don't just kick them out for not turning on the camera. Nina – can't you all just change the pw instead of the meeting id? Jeff – we don't change the meet id. But how do ppl use the pw if we don't give it to them? That's why we enabled the waiting room because there is no way to give the pw out if we don't know who you are.
